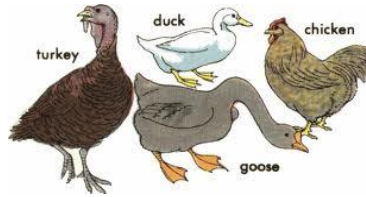


# POULTRY



## Rules & Regulations for the 2012 Hernando County Fair Youth Livestock Show & Sale



1. Exhibitors must be at least 5 years old on September 1, **2011**. Exhibitors must not have graduated from high school. Exhibitors must be enrolled in and attending a school, at the time of the show and sale. Exceptions can be made for youth graduating early (i.e. December) of the project year. Only youth within the above age group, who are enrolled in a Hernando County 4-H or FFA Club/Chapter, (***in good standing***), will be eligible to enter the Poultry Show.
  - Anyone actively showing livestock in another County Fair, other than open shows, will **not** be allowed to enter an animal in the Hernando County Fair, unless it's something that the Hernando County Fair does not offer. (The only exception will be the State Fair).
  - Exhibitors to Hernando County from other counties must submit a letter to the Livestock Committee, expressing their reason for wanting to show in Hernando and not their County of residence. Approval may be allowed, after the HCFAYLC has contacted the County in which they reside, and verified the reasons to be true and justified. (*If you have submitted a letter previously, and it was approved by the HCFAYLC, then that letter will suffice through your high school graduation*).



2. All animals must be at least six (6) months of age as of April 5, 2012.



3. **Exhibitors cannot compete against themselves.** There is a limit of 1 entry per class, (up to 8 poultry maximum), per exhibitor. The HCFA has limited cage space available, cages will be assigned on a first come, first serve basis. Once cages have been filled no other entries will be accepted.

### **THERE MUST BE AT LEAST THREE ANIMALS IN EACH CLASS, IN ORDER TO QUALIFY FOR A SHOW IN THAT CATEGORY.**



4. Entry Forms are attached to the last page of the Rules and Regulations packet.
  - There is a \$3.00 non-refundable entry fee, per Poultry entry.
  - Entry Form and Entry Fee **MUST** be received by 4:00 p.m. on February 1, 2012. (*Must be postmarked by this date for acceptance*).

5. Mailing address for submitting Pre-registration Entry Forms and Entry Fee is:

6. No sick or diseased animals will be allowed. All animals will be inspected at Fair check-in.



7. The HCFAYLC would like to emphasize: General care, grooming, cleaning of cages, feeding and watering of animals. This will be the responsibility of the Exhibitor, with assistance only from an Advisor/Leader/Agent, HCFAYLC member, or a fellow exhibitor. Care and feeding includes providing feed, water, etc.

- Feeding of animals should be done at least once a day, and must be completed by 9:00 p.m. each day.
- Each exhibitor will be responsible for cleaning in, around and UNDERNEATH their animals' pen DAILY.
- Additional care may be provided, at the discretion of the HCFAYLC.



8. The HCFAYLC will be using a Yellow and Red Tag Penalty System for making sure all animals are cared for and that the area in and around their pens are maintained. If a member of the HCFAYLC observes that your animal or your pen is being neglected you will receive a Yellow Tag, with the reason for it written on the tag. If the same problem for lack of care is noted again, you will be given a Red Tag and **fined**. ***Please make sure your animal is well fed, watered, and that the area in and around your pen is clean, so that fines can be avoided.***



9. The Hernando County Fair Association Youth Livestock Committee will sponsor a Herdsman Award.



9. All Poultry must be at the fairgrounds on the date and time designated by the HCFAYLC for Fair Check-in. Youth exhibitors registering the animals **MUST** be present at check-in.

### **Fair Check-in:**

**April 5, 2012 from 4:00 - 6:00 p.m.**

10. Exhibitors are to conduct themselves in a proper manner as ladies and gentlemen at all times.



11. Beginning August 28, 2011, The Rules and Regulations will be available for pick up from the Fair Office, Monday – Friday from 9:30 a.m. until 4:00 p.m. (*If coming during lunch hours, please call first 796-4552*). Copies of the Rules & Regulations may also be download from the Fair Website at: [Hernandofairgrounds.com](http://Hernandofairgrounds.com). Any additional rules will be reviewed at the mandatory events or e-mailed to you. Violations of any written or expressed rule may result in disqualification.



- 12. Poultry cages must be completely cleaned out on load out day by the time designated by the HCFAYLC, or a cleaning fee will be deducted from your premium check. Exhibitors are responsible for checking in with the designated Livestock Committee member in the Barn area.

**CLEAN-UP IS MANDATORY FOR ALL LIVESTOCK EXHIBITORS**

**Clean-up is April 15, 2012 beginning at 1:00 p.m. until finished.**

**No cleaning will begin until 1:00 p.m., if you show up early you will be asked to leave and return at 1:00 p.m. - NO EXCEPTIONS!**



- 13. All persons working with or around animals, or assisting youth working with or around animals, (including adults), must wear ONLY closed, non-steel toed shoes with backs.



- 15. The Hernando County Fair Association will sponsor an All Star Award. The All Star Award will be based on the following criteria:

- a.) Exhibitor performance at Fair.
- b.) Exhibitor's Grade Point Average - Exhibitors are responsible for contacting their school for a certified copy of their **current GPA**. Return you certified current GPA, to the Fair Office in a **SEALED** envelope with your name on it, by 4:00 p.m. on Monday, April 2, 2012.



- 14. All Poultry will be judged in their cages. The Poultry Showmanship Classes will be held on Saturday, April 6, 2012 beginning at 6:30 p.m.



- 15. **Showmanship is MANDATORY** - (Showmanship is optional for Youth ages 5 - 7 as of September 1, 2011).



- 16. All exhibitors must wear dark black pants, a solid white shirt (collared & button down), and either dark black or dark brown shoes. 4-H exhibitors must wear their 4-H green representation. FFA exhibitors must wear either a blue or black tie, or scarf and their FFA jacket (zipped). No hats are permitted!

**Exhibitors NOT in Official Dress will have their show premiums forfeited.**  
***(This applies to exhibitors ages 5 - 7 as well).***



- 17. Appropriate and proper **handwritten** thank you letters to all **Belt Buckle Sponsors**, must be turned in at the Barn Office in an unsealed, stamped, addressed envelope on April 15, 2012 at the end of Clean-up. Should deadline be missed, premium money will be forfeited.



18. The Fair Office will notify you, (**per your preferred method of contact**), once your premium checks are ready.
19. Failure to comply with any of the above rules and regulations will subject the exhibitor to disqualification and removal from the project or fairgrounds.



## **IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) CODE OF SHOW RING ETHICS**

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing.
5. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and

correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

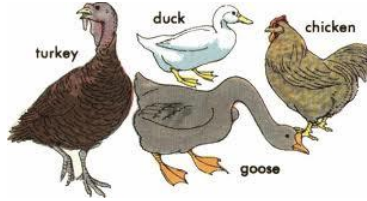
6. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
7. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
8. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
9. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
10. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
11. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including *Fairs and Expos* and any special notices to members.
12. The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
