Rules, Regulations IAFE National Code of Show Ring Ethics and Entry Form for the 2012 Hernando County Fair Youth Livestock Show & Sale


As a condition of acceptance and in return for the opportunity to enter projects with the intent of striving toward qualifying for the Hernando County Youth Livestock Shows and Sales, all participants agree to abide by these rules and accept their interpretations and administration as set forth herein. Any violation of these rules will result in monies being withheld and/or could disqualify Exhibitor from the show and/or sale of the current year and/or the following year. Final interpretation and administration of these rules will be vested in the Hernando County Fair Association's Youth Livestock Committee (HCFAYLC).


GENERAL STEER PROGRAM RULES:


1.  Exhibitors must be at least 8 years old as of September 1, **2011**. Exhibitors must not have graduated from high school. Exhibitors must be enrolled in and attending a school, at the time of the show and sale. Exceptions can be made for youth graduating early (i.e. December) of the project year. Only youth within the above age group, who are enrolled in a Hernando County 4-H or FFA Steer project, (*in good standing*), will be eligible to enter the Steer Show & Sale.
 - Anyone actively showing livestock in another County Fair, other than open shows, will **not** be allowed to enter an animal in the Hernando County Fair, unless it's something that the Hernando County Fair does not offer. (The only exception will be the State Fair).
 - Exhibitors to Hernando County from other counties must submit a letter to the HCFAYLC, expressing their reason for wanting to show in Hernando and not their County of residence. Approval may be allowed, after the HCFAYLC has contacted the County in which they reside, and verified the reasons to be true and justified. (*If you have submitted a letter previously, and it was approved by the Livestock Committee, then that letter will suffice through your high school graduation*).

2.  The HCFAYLC will inform Exhibitors of all Mandatory Events. Exhibitors will be **fined \$50.00** for the first event they do not attend. Exhibitors will not be allowed to participate in the Hernando County Fair Youth Livestock Show & Sale if they miss two mandatory events. Exhibitors will be notified, prior to the mandatory events, with time to make arrangements to attend. The following is a list of the Mandatory Events currently scheduled:
 - **Mandatory Exhibitor and Parent/Guardian meeting at the fairgrounds on November 12, 2011, beginning at, (*time to be announced*), until finished.**
 - **Mandatory Workday is scheduled for all Steer exhibitors on Saturday, March 31, 2012 beginning at 9:00 a.m. and ending at Noon. (*If you are showing both a Steer & Swine Project you must attend the 9:00 a.m. - Noon session*).**
 - **Mandatory Exhibitor and Parent/Guardian Meeting from 12:30 p.m. - 1:30 p.m. following the mandatory Workday, on Saturday, March 31, 2012.**

3.  Youth exhibitors must complete a Mandatory Workday, specified by the HCFAYLC. The date and time of that mandatory workday is **Saturday, March 31, 2012, beginning at 9:00 a.m. - until Noon**. If you are unable to attend this Mandatory Workday, a **make-up date of Sunday, April 1, 2012**, has been set aside, (*time to be announced*). Any Youth needing to complete their mandatory workday on a date other than the ones offered, must call the Fair Office, at 796-4552, at least **one week prior** to the scheduled workdays, to pre-arrange a date and time. You **must** have a compelling reason for an alternate date.


4.  Individual youth exhibitors may enter only one steer entry, and may enter a single back-up steer. Two or more youth exhibitors of the same family, residing in the same household, may register a single back up animal, and anyone of the eligible youth may use this animal as their final project.


5.  4-H Clubs and/or FFA Chapters may enter up to **two (2) Steers** in the show and sale..


6.  Record books must be complete and turned in at the final weigh-in on **April 10, 2012**, no later than 9:00 p.m. Failure to turn in a completed record book by the stated deadline will result in disqualification of the Exhibitor from all shows, and the animal will be sold at the buyback price. If the Exhibitor is disqualified, no across the board add-ons will be awarded. A completed record book **MUST** be turned in. **Record book competition is MANDATORY.** (*There will be an average daily weight gain contest*).

For Record Book purposes, use 178 days, when figuring average daily gain for Steer.

7. Exhibitors are to conduct themselves in a proper manner as ladies and gentlemen at all times.

8.  Beginning August 28, 2011, The Rules and Regulations will be available for pick up from the Fair Office, Monday – Friday from 9:30 a.m. until 4:00 p.m. (if coming during lunch hours, please call first 796-4552). Copies of the Rules & Regulations may also be download from the Fair Website at: Hernandofairgrounds.com. Any additional rules will be reviewed at the mandatory events or e-mailed to you. Violations of any written or expressed rule may result in disqualification.

9.  Entry Forms are attached to the last page of the Rules and Regulations packet.
- **There is a \$10.00 non-refundable entry fee for each steer exhibitor. The \$10.00 entry fee may be paid in advanced if you pre-register, otherwise bring your \$10.00 entry fee and entry form with you when you come to the initial steer weigh-in on Saturday, October 15, 2011 from 8:00 a.m. - Noon.**

10.  The Hernando County Fair Association has a limit of 46 steer stalls available. Spaces will be reserved on a first come first serve basis, once the spaces have been filled, no other entries will be accepted.

PRE-REGISTRATION IS STRONGLY SUGGESTED.



11. Youth Exhibitors must show proof of ownership of their animals. Proof of ownership shows that you own, and have possession of your animal at the time of initial weigh-in, (October 15, 2011). Proof of ownership shall be on the Official Breeder's Certificate, which is in your Rules & Regulations packet.

- If you pre-register, you may submit your Breeder's Certificate, along with your entry form and entry fee.
- If you are not pre-registering, you **MUST** bring the Breeder's Certificate with you to initial weigh-in on October 15, 2011 – NO EXCEPTIONS.

Breeders Certificates/Purchase Agreements MUST be shown, prior to unloading your animal.

13. If an Exhibitor has submitted Proof of Ownership or a Purchase Agreement, as prescribed above on more than one animal, exhibitors can only bring one steer to the final weigh-in. If the Steer brought to the final weigh-in does not meet the requirements of eligibility, no secondary animals will be allowed to be entered. Animals will only be allowed to weigh once at the final weigh-in. Once your animal has been weighed, if it does not meet the minimum requirements, it will be accepted for a lightweight showmanship class only and will be sold last.



14. The maximum allowed weight for a steer at initial weigh in is 1000 pounds. It is recommended that Exhibitors start with a beef type steer that will weigh at least 700 pounds by the initial weigh in. *(Each exhibitor will receive a weight verification sheet - carbon copy. This weight verification sheet will be signed by the exhibitor, and at least one member of the HCFAYLC).*



15. Steers must achieve an Average Daily Weight Gain of no less than 2.0 pounds per day to be eligible to show and/or sell. Steers must weigh a minimum of 900 pounds at final weigh-in on **April 10, 2012**. Steers weighing more than 1350 pounds will be sold at 1350 pounds. *(Each exhibitor will receive a weight verification sheet -carbon copy. This weight verification sheet will be signed by the exhibitor, and at least one member of the HCFAYLC).*

16. All animals must be identified by ear tags and permanent tattoo at initial check-in. If an ear tag is lost the Exhibitor must notify, their FFA advisor, 4-H Leader/Agent, or the HCFAYLC prior to final weigh in.



17. No animal may be exhibited in competition that cannot be properly managed or led into the show/sale ring by the Exhibitor. Any Member of the HCFAYLC may also check animals prior to show at Exhibitor's home. Any animal acting in a manner which endangers other Exhibitors will be directed to leave the show ring. A Committee Co-Chair will notify show judge and/or ring stewards of this decision. Animals unable to be shown or asked to leave a ring per this rule, will be sold before the lightweight class.



18. All animals must be at the fairgrounds on the date and time designated by the HCFAYLC for initial and final weigh-ins. Youth Exhibitors registering the animal **MUST** be present at both the initial and final weigh-ins.

Exhibitors Please Note: If the trailer your animal is riding in is ready to unload, and you are not present, your animal will not be allowed to unload ~ make sure you are there!

Initial Weigh-in:

**Saturday, October 15, 2011 from 8:00 a.m. - Noon.
Exhibitors and animals must be in line by: 10:00 a.m.**

Final Weigh-in:

April 10, 2012 from 2:00 - 5:00 p.m. - (Early weigh-in)

OR

**April 10, 2012 from 6:00 - 7:00 p.m. - (Late weigh-in)
Exhibitors and animals must be in line by: 6:30 p.m.**

19. Vehicles transporting animals to all events are required to be cleaned and disinfected just prior to moving the animal to the fairgrounds. No unloading or bringing into the tack or stall area of any supplies, grooming chutes, etc., will be allowed during final weigh-in. If you have supplies on your trailer they must be placed in front of your animals. Exhibitors having supplies that must be removed to unload their animal will be sent to the end of the line. All equipment must be kept in their Designated areas for the duration of the fair.



20. Health Regulations are subject to the Florida Department of Agriculture regulations in effect at the time. The Fair Office will keep you informed of these regulations. No animal showing visible signs of illness or infestation will be accepted at the fairgrounds. Any animal displaying warts at either initial check in or final weigh-in will not be permitted off the trailer (unless approved by a veterinarian or designee), and will be refused entry into the fair. **All Steers will be inspected, prior to unloading.**
21. Exhibitors will be assigned stall space by the HCFAYLC. Limited bedding will be provided by the management, but each Exhibitor will be responsible for keeping his/her area clean and neat during the fair.



22. The HCFAYLC would like to emphasize: General Care, grooming, cleaning of stalls, and feeding of animals will be the responsibility of the Exhibitor, with assistance only from advisor, 4-H leader, Livestock Committee, or fellow Exhibitor. Care and feeding includes providing feed, hay, pails, tie ropes, etc. . . Steer should be exercised daily. Hay nets and hay bags are prohibited.

- Feeding of animals must be completed by 9:00 a.m. in the mornings, and an hour after show is complete in evening, (or by 9:00 p.m., if there is not a show going on).
- There will be no feeding, watering or bathing of animals during any livestock show.
- Additional care may be provided, at the discretion of the HCFAYLC.



23. The HCFAYLC will be using a Yellow and Red Tag Penalty System for making sure all animals are cared for and that the area in and around their stalls are maintained. If a member of the HCFAYLC observes that your animal, or your stall is being neglected you will receive a Yellow Tag, with the reason for it written on the tag. If the same problem for lack of care is noted again, you will be given a Red Tag and **fined \$50.00.** *Please make sure your animal is well fed, watered, and that the area in and around your stall is clean, so that fines can be avoided.*



24. The Hernando County Fair Association Youth Livestock Committee will sponsor a Herdsman Award.

25. Regardless of the time of the sale, actual ownership will not change hands until the announced time of release. Each Exhibitor will be responsible for the well-being of their animal until the time of release, at which time (if proper care has been maintained) the Steer will become the property of the purchaser. No stall is to be vacated until the announced release time.



26. All exhibitors must wear dark black pants, a solid white shirt (collared & button down), and either dark black or dark brown boots. 4-H exhibitors must wear their 4-H green representation. FFA exhibitors must wear either a blue or black tie, or scarf and their FFA jacket (zipped). No hats or sneakers are permitted!

- **Exhibitors NOT in Official Dress, will NOT be allowed to show, and their animal will be sold at buyback price.**


27. All persons working with or around animals, or assisting youth working with or around animals, (including adults), must wear ONLY closed, non-steel toed shoes with backs.



28. The Hernando County Fair Association will sponsor an All Star Award. The All Star Award will be based on the following criteria:

- a.) Exhibitor performance at Fair.
- b.) Exhibitor's Grade Point Average - Exhibitors are responsible for contacting their school for a certified copy of their **current GPA.** Return you current GPA to the Fair Office in a **SEALED** envelope with your name on it, by 4:00 p.m. on Monday, April 2, 2012.


29.  Showmanship is MANDATORY.


30.  Steer stalls must be completely cleaned out on load out day by the time designated by the Livestock Committee, or a stall cleaning fee of \$50.00 will be deducted from the total sales price and Steer check payment. Exhibitors are responsible for checking in with the designated Livestock Committee member in Steer area.

Load-out is April 15, 2012 at 7:00 a.m. - (*OPTIONAL for exhibitors*).

CLEAN-UP IS MANDATORY FOR ALL STEER EXHIBITORS


**Clean-up is April 15, 2012 beginning at 1:00 p.m. until finished.
No cleaning will begin until 1:00 p.m., if you show up early you will be asked to leave
and return at 1:00 p.m. - NO EXCEPTIONS!**

31.  Exhibitors are encouraged to weigh their animals periodically during the feeding period. To assist in this, the HCFAYLC, agrees to have available the scale and persons to assist the youth exhibitor on the first Tuesday of every month beginning at 6:00 p.m. Pre-registration is required by 4:00 p.m. the Monday before. Please call the Fair Office at 796-4552. Registered projects only!

32.  Steers over 24 months of age on or before April 1, 2012 will not show.



33. All steers must be dehorned and castrated prior to initial weigh-in for acceptance into youth steer Show/sale. Scurs can't be longer than 1" over hairline at either initial or final weigh in. Steers brought to the initial weigh in not meeting the previous requirements will not be allowed entry into the Youth Steer Show.

34.  **All steers must be secured with halters AND neck ropes simultaneously.**

35.  The Steer Show & Showmanship Classes will be held on April 13, 2012 beginning 6:30 p.m.


2012 Sale Order: Swine, Pen of Meat Chicken, Pen of Meat Rabbit and then Steers.


SALE RULES:


1.  **ALL Market Animal Sale** will be held on April 14, 2012 beginning at 11:00 a.m.
2. As a condition of acceptance in the sale, Exhibitor (seller) agrees that all animals in the sale must be sold. No buyer is obligated to buy. There is no certain price per pound guaranteed
3.  To assure that a sufficient number of buyers are present at the Sale, Exhibitors are **STRONGLY** encouraged to write letters to multiple prospective buyers. If you are unsure how to do this, or need help, please ask your 4-H Leader, FFA Advisor, or contact a member of the HCFAYLC and they will be happy to assist you in putting a buyer's letter together.

Information that should be included in your Buyer's Letters:







- Advise the Prospective Buyer to enter the Fair through the **VENDOR GATE**, where they and one (1), guest will receive **FREE** admission. *(If you know of a prospective buyer that will be coming who will have more than 1 guest with them, please contact the Fair Office so that arrangements can be made).*
- Once inside the VENDOR GATE, they will need to proceed to the Barn, where they will register themselves, or their company at the Barn Office, *(Registration does **NOT** commit them to purchase an animal).*
- For your benefit a copy of the Bidder's Information Guide is located on the Fair Website for download, or you may pick up a copy at the Fair Office, so that you can make copies and include them with your buyers letters.. **Bidder's Information Guides will be available beginning January 9, 2012.**

4.  The Buyer's Lunch will begin at 2:00 p.m., ***(Buyer's Lunch is for Buyer and one guest, per animal purchased)***,
5. Six percent (6 %) of the sale price will be deducted to help cover the costs of the sale and advertising. **No percentage will be deducted from the add-ons.** Steer check-off dollar will be deducted and distributed in accordance with federal regulations.

6.  The Hernando County Fair Association helps sponsor the Youth Livestock Shows and Sale to encourage and to provide an opportunity for youth to learn from a livestock project, to exhibit animals which qualify and sell their accepted animals at an open auction which offers an opportunity for a rewarding sale price. The HCFA, et al, serves only as an agent for the Exhibitor and seller. ***(They gain no profit from the sale or add-ons - 100% of add-on's are given to the exhibitors)***. Monies paid for the animals, add-ons, etc., will be dispersed to the seller when all monies due are received. The deduction of a percentage is used to help defray the costs of advertisement and selling costs on behalf of the seller.

7.  All Exhibitors will pay their bills relating to their project within 30 days of checks being issued. The HCFAYLC reserves the right to refuse entry into the show, or subsequent shows, because of any failure of Exhibitor to uphold their financial responsibilities relative to their project. This includes any monies owed to a farmer, rancher, individual, feed mill, or store who supplied/provided an animal, boarding, tack, feed or hay to an Exhibitor, with the promise of payment to them,

once monies were received from the HCFA, and said promise has not yet been fulfilled. The exhibitor will **NOT** be allowed to show any animals at the Hernando County Fair until said debts have been paid in full. The debtee must contact the Fair Association to advise that said debt has been paid in full.

8.  Appropriate **handwritten** thank you letters to **Steer Buyers** and **Belt Buckle Sponsors**, must be turned in at the Barn Office in an unsealed, stamped, addressed envelope on April 15, 2012 at the end of clean up.
9.  Exhibitors Add-on list will be ready for **pick-up on Monday, April 30, 2012 by 9:00 a.m.**; please do **NOT** call the Fair Office prior to this date requesting your information.
10.  Appropriate and proper **handwritten** thank you letters for all **add-ons** must be turned in to the Fair Office by 4:00 p.m., on May 14, 2012. All thank you letters must be in an unsealed, stamped, addressed envelope.
11.  Should the Fair Office receive any Add-on's for an exhibitor, **after** they have picked up their Add-on List, then the exhibitor will be contacted, (per his/her preferred method). Thank You letters for these add-on's must be turned in before sales checks are received.
12. **Exhibitors will be charged \$50.00 per buyer, add-on and/or belt buckle for each appropriate thank you letter not received by the deadline. Youth are encouraged to turn letters in early so they can be reviewed and replaced if necessary. (Be sure each Thank You Letter has a greeting and salutation).**
13.  The Fair Office will notify you, (*per your preferred method of contact*), once your Sales Check is ready for **pickup**.
14.  Any exhibitor making **\$5,000.00 or more** will have to have a **W9** - Federal Tax regulation requires the Hernando County Fair Association (HCFA) to obtain Social Security Numbers (SSN) or Taxpayer Identification Number (TIN) from exhibitors whom compensation over \$5,000.00 is paid. SSN or TIN are maintained and used by HCFA for the processing of payments due, and are reported to Federal and State agencies on forms required by law. HCFA will not disclose any SSN or TIN without your consent to anyone outside HCFA, except as mandated by law. Failure to provide a SSN or TIN will result in denial of compensation.

IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing.
5. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter,

trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

6. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
7. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
8. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
9. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
10. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
11. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including *Fairs and Expos* and any special notices to members.
12. The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
