2025 Rules, Regulations and Entry Form for the Hernando County Fair Open Youth Poultry Tailgate Show

Virtual Sign-up ONLY:

Monday, March 18th through Monday, April 8th, 2025

Online registration open March 18th through April 8th 2025, forms available via Fair Website www.hernandofairgrounds.com, Registration forms will need to be emailed to the Livestock Committee <a href="https://hernandocom.hernandoc

The Poultry Show will be April 26, 2025 at 1:00 p.m. Please bring your poultry in appropriate cages for check in on April 26^{th} , 2025 from 8:00 a.m. to 10:00 a.m.

- 1. Entry Form will allow you to enter all of your birds. Starting March 18th, 2024 and MUST be received by 4:00 p.m. on Tuesday, April 8th, 2025. When registering your bird(s), make sure you fill in the entry Form COMPLETELY (CLASS #, BREED AND VARIETY MUST BE FILLED IN. There will be NO changing of forms, once it is turned into the office.) Once your bird(s) have been registered in a Class, there will be no Class changes allowed. Any changes to Entry Form MUST be approved by the HCFAYLC. No cost to enter.
- 2. Exhibitors may show up to (6) birds. Birds must be at least six (6) months of age as of April 7th, 2025.
- 3. **Poultry CHECK-IN:** Saturday April 26th, 2025 from 8:00 a.m. 10:00 a.m. Youth exhibitors registering Poultry <u>MUST</u> be present for check-in.
- 4. **Poultry Judging**: Poultry Judging will take place on Saturday, April 26th, 2025 at 1:00 pm. Prizes: Grand prize Purebred \$50.00 Reserve Grand Purebred \$25.00 Grand prize Crossbred \$50.00 Reserve Grand Crossbred \$25.00.
- 5. Unbecoming conduct on the part of an exhibitor will at the discretion of the Hernando County Fair Association, (HCFA), result in disqualification of the exhibitor and require immediate removal of the animal/s and the exhibitor from the Fairgrounds with the loss of awards, premiums, show is a privilege. Profanity at any Fair event will result in disqualification.
 - Unbecoming conduct with <u>ANY individual</u> associated to an exhibitor on the Fairgrounds will result in removal of that person/persons from the grounds.
- 6. Health Regulations are subject to the Florida Department of Agriculture regulations in effect at the time. The Fair Office will keep you informed of these regulations. No animal showing visible signs of illness or infestation will be accepted at the Fairgrounds.
- 7. Exhibitor assumes responsibility and liability in the event of loss, death or injury of his/her animal/s. The Hernando County Association is not responsible for the health or safety of any animal entered or exhibited.
- 8. In the event of government or HCFA imposed quarantine of animal(s) entered for exhibit at The Hernando County Fair Youth Livestock Show, the HCFA accepts no responsibility for financial or other loss by the exhibitor that occurs as a result of the inability to exhibit and/or market the animal(s). Government refers to any City, County, State, or Federal agency with the legal power to impose such quarantine. The preceding statement pertains to the entire time period (prior to, during, or after the exhibit days) of the show. Financial, or other, loss refers to financial loss due to the inability to loss of premiums and awards due to the inability to exhibit the animal.
- 9. The Fair Office will notify you once Checks and/or premiums are ready for pickup.
- 10. All rules are subject to change based on CDC Guidelines or current Government rules, regulations, or restrictions.
